InCred Holdings Files Confidential DRHP With Sebi To Launch IPO

InCred Holdings, led by Bhupinder Singh, confidentially filed DRHP with SEBI as it eyes capital markets.

New Delhi.(Agency)

InCred Holdings, the 100% holding company of InCred Financial Services Limited (InCred Finance), has confidentially filed its draft red herring prospectus (DRHP) with the Securities and Exchange Board of India (SEBI), as per the public announcement. The company, part of Bhupinder Singh founded InCred Group, is looking to tap the capital markets.

According to several reports, the IPO size could be in range between Rs 4,000-5000 crore. The IPO will comprise of fresh issue as well as an offer-for-sale. InCred Finance is part of InCred Group, a diversified financial services group that has three distinct business – 'InCred

Finance' the lending focused NBFC, 'InCred Capital' the integrated institutional platform and 'InCred Money' which is the retail wealth-tech investment distribution vertical.

The marquee investors are Abu Dhabi Investment Authority, TRS (Teacher Retirement System of Texas), KKR, Oaks, Elevar Equity, and Moore Venture Partners. Since inception in 2016, InCred Finance has disbursed loans worth over Rs 25,000 crore, serving more than 4 lakh customers through a network of 140+ branches and a workforce of 2,600+ employees. Personal Loan, Student Loan, Specialised MSME Loan, Secured Business Loan and Loans for Financial Institutions.

Infosys Buyback Record Date 2025: Know The Tax Rules Before Submitting Your Shares

IT firm Infosys has already announced Friday, November 14, 2025, as the record date for its largest-ever share buyback at a price of Rs 1800 per equity share amounting to Rs 18,000 crore. It means shareholders will need to hold Infosys shares on the record date to be eligible to participate in the buyback. A buyback (or share repurchase) is when a company buys its own shares from existing shareholders, usually at a price higher than the market rate. The Board of Directors of the company at their meeting held on September 11, 2025, has considered and approved a proposal to buyback equity shares for an amount of Rs 18,000 crore at a price of Rs 1,800 per equity share," Infosys

said in an exchange filing previously. **Infosys Share Buyback: How To Apply?**

If you want to participate in an Infosys



buyback, here's the step-by-step process:

1. Check the record date and ensure your Infosys shares are in your demat by that date. It is important to note that the record date has not been announced yet.

Bomb Threat To Malaysian Airlines Flight From Kuala Lumpur To Chennai Proves To Be A Hoax

Chennai : Panic erupted at Chennai airport on Sunday morning after the airport director's office received an email threat around nine thirty am, claiming that a Malaysian Airlines flight from Kuala Lumpur was carrying powerful explosives.

The flight, which had one hundred twenty-nine passengers and eight crew members on board, landed safely at the Chennai airport at ten forty am, where emergency protocol was immediately implemented.

Following the threat, a high-level emergency meeting was convened, involving airport security officials, the Bureau of Civil Aviation Security,

bomb disposal experts, and the police forces.

Upon landing, all one hundred thirty-seven occupants were safely evacuated, and bomb disposal squads along with sniffer dogs conducted an extensive search of the aircraft and passenger baggage. After thorough checks, officials confirmed that the bomb threat was a hoax and no suspicious objects were found.

In an update, the same aircraft, which was scheduled to depart for Kuala Lumpur at eleven forty-five am, took off around twelve forty pm, following an hour's delay due to the comprehensive security checks.

अतिवृष्टी अनुदान वितरणात सुलभता येण्यासाठी अंग्रीस्टॅक नोंदणी आवश्यक रविवारी प्रत्येक गावात विशेष कॅम्प

छत्रपती संभाजीनगर, दि. ९ : फार्मर आय डी अर्थात अंग्रीस्टॅक नसल्या मुळे अनेक शेतकऱ्यांचे अतिवृष्टी मद्दत अनुदान त्यांच्या खात्यात जमा होण्यास अडचण निर्माण होत आहे. जिल्ह्यात १ लाख ३१ हजार ७६५ शेतकऱ्यांची अंग्रीस्टॅक नोंदणी अद्याप प्रलंबित आहे. अंग्रीस्टॅक नोंदणी करण्यासाठी रविवार दि.९ रोजी प्रत्येक गावात विशेष कॅम्पचे आयोजन करण्याचे निर्देश जिल्हाधिकारी दिलीप स्वामी यांनी दिले आहेत. यासंदर्भात निवासी उपजिल्हाधिकारी जनार्दन विधाते यांनी माहिती दिली की, जिल्ह्यात १३३१ गावांमध्ये ६ लाख ३१ हजार ७८ शेतकरी आहेत. त्यापैकी ४ लाख ९९ हजार ३१३ शेतकऱ्यांनी अंग्रीस्टॅक नोंदणी केली आहे. अद्याप १ लाख ३१ हजार ६५ शेतकऱ्यांनी नोंदणी झालेली नाही. तर

४८ हजार ३५९ अंग्रीस्टॅक नोंदणी केलेल्या शेतकऱ्यांच्या नोंदणीस मान्यता नाही. शून्य ते २ हेक्टर पर्यंतच्या ६ लाख ४४ हजार ६४९ शेतकऱ्यांना एकूण बाधीत ५१९४६५.७४ हेक्टर क्षेत्रासाठी ४८० कोटी १७ लाख ३ हजार रुपये इतके अनुदान मंजूर आहे. त्यापैकी ४ लाख ६३ हजार १४९ शेतकऱ्यांची नावे अनुदानासाठी अपलोड करण्यात आली असून त्यांची एकूण रक्कम ३५७ कोटी २० लाख ३४ हजार रुपये इतकी आहे. प्रत्यक्षात आतापर्यंत २ लाख ८७ हजार ७५९ शेतकऱ्यांना २१५ कोटी ६४ लाख ७३ हजार रुपये इतके अनुदान वाटप झाले आहे. तर २ ते ३ हेक्टर क्षेत्र बाधीत असलेल्या ४१ हजार १२९ शेतकऱ्यांपैकी १२ हजार ७६७ शेतकऱ्यांचे अनुदान ६ कोटी ४५ लाख १२ हजार रुपये इतके
